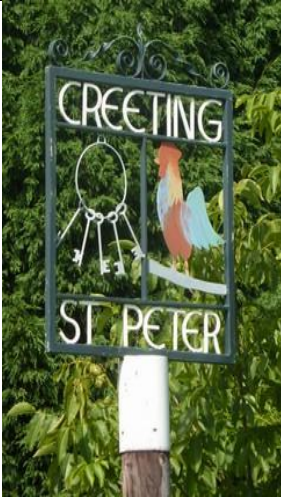

## A few words from the Chair...

If I had thought for one moment that chairing the Parish Council was going to be easy, recent events have demonstrated that there is no such thing as "too quiet". So, time for a quick run-through of what's happened over the past few months...

**We've got a new County Councillor** in Keith Welham, who won the Stowmarket North and Stowupland division by 139 votes over outgoing Cllr Gary Green. Keith is familiar with our issues here, having served as our District Councillor between 2015 and 2019, and has hit the ground running. We look forward to working with him in the years ahead.

**We've also got a new Parish Councillor** in Lynne Jardine, who was co-opted at our Annual Parish Council meeting in May. She has already set to work on issues relating to Poundfield and the local footpaths on the western side of the Parish, and we're pleased to have her onboard.

**No news from Gateway 14.** Despite the initial expectations that the planning application would be heard by Mid Suffolk District Council at the beginning of the year, there is still no sign of a date for its hearing. Both the Residents Campaign Group and the Parish Council have made full submissions, as have many of you as individuals, although the remaining delays seem to revolve around highways, with Highways England having sought a delay until mid-September whilst their concerns are addressed.

**Mid Suffolk District Council says no to extended hours for Poundfield.** After more than eighteen months of uncertainty, the application was rejected – the company failed to supply the required noise and light reports required. The Parish Council will now focus our attention on seeking enforcement of the existing operation hours restrictions, and welcome reports of working outside those hours. The conditions are as follows;

*No machinery shall be operated, no process shall be carried out and no deliveries taken at or despatched from the site outside of the following times;*

*8 a.m. to 6 p.m. Monday to Friday and 8 a.m. to 1 p.m. on Saturdays with no working on Sundays or on Bank Holidays.* Please send your reports to our Parish Clerk ([pc@creetingstpeter.suffolk.gov.uk](mailto:pc@creetingstpeter.suffolk.gov.uk)).

**An appeal for the "Meadows" site.** Residents of the surrounding properties will be aware that an appeal has been made to the Secretary of State regarding the second refusal of planning permission to demolish the property and build four new ones in its place. The Planning Inspector will consider all of the evidence already submitted, and Mid Suffolk District Council are expected to actively defend their position given the potential impact on the Local Plan. We have no timeline for any announcement.

**New street lights?** Residents of the core village will know that our ten street lights are not in good condition, and some of them have been out of order for some time. They're expensive to maintain and increasingly obsolete. Suffolk County Council have announced a programme of replacing some 43,000 street lights with modern LED versions, and there is a possibility that we might be able to piggyback on that. We'll keep you updated on that.

**An e-newsletter for Creting St Peter?** One of the key lessons from the pandemic is finding better ways to keep residents informed. Producing newsletters and delivering them by hand is slow and expensive, whereas if we could e-mail them to most residents, it would cut costs, allow us to issue newsletters more frequently, and improve our reporting back. We need to make sure that we're GDPR compliant though, and that those who don't, or can't, use the Internet aren't excluded. However, we'll be looking to seek your agreement to this over the coming months so, if one of us knocks on your door, don't be too surprised.

Finally, life is slowly returning to something more familiar as normal. However, there are still those amongst us who need support, and I know that many of you are looking out for friends and neighbours. Thank you to everyone who has gone out of their way to help, and whilst the path out of the pandemic is still a bit fuzzy, I'm hopeful that this will continue as long as it is needed.

#### **County Councillor Keith Welham's Report:**

**Bus Back Better** - Bus Back Better is being launched by central government, essentially as a response to Covid 19, but it could lead to re-regulation of bus services and could be a positive move for rural Suffolk. The de-regulation of services, as we have at present, has led to the decimation of rural services in many communities, as this policy renders it unlawful to cross-subsidise routes. Re-regulation would allow an operator to cross-subsidise, and this should lead to greater choice and better services to our rural communities. Government requires public transport authorities to produce a Bus Service Improvement Plan (BSIP) and bid for funding. There is also an offer of 4,000 zero emission electric buses that can be bid for. Based on population, Suffolk's share could be 40.

**A14 Night Time Closures** - Closure from 8.00 pm to 6.00 of sections of A14 to allow the erection of large signs, and also pavement condition surveys, will be undertaken from late July to 11 August. Diversions will be signed via A143 and A140. I have expressed concern about the likelihood of traffic using A1120 or local roads instead. And, also, which routes will be signed to and from Stowmarket when the Stowmarket junctions are closed.

**Infrastructure delivery Plan** - I met with a member of SCC Infrastructure Team to discuss highways, education and health issues. Proposals currently include a new nursery school on the Taylor Wimpey land in Stowupland and on the Diapers' Farm development on the edge of Stowmarket and an increase in primary school places. SCC would prefer to see Freeman School enlarged but, if this is not acceptable to the Academy Trust, a new school will be provided on the Taylor Wimpey site. SCC accept that a roundabout will be required at the B1115/A1120 junction. I have requested a meeting with a representative of the health authority to discuss provision of a new health centre, preferably on the Diapers' Farm development or an alternative site accessible to residents of Creting St Peter and Stowupland.

**Gateway 14** - I have met a number of times with the Gateway 14 Campaign Group to discuss a range of issues. I will continue to push for a road improvement to bypass Clamp Farm Corner. I have asked for a site meeting with a highways officer to discuss the condition of Mill Lane and discuss its suitability for a likely increase in traffic during construction of the business park and as a rat run to and from Cedars Park, Tesco stores etc. So far requests for such a meeting have been refused. I am planning to raise highways issues in any meeting arranged to discuss the development with MSDC officers and councillors, and with the developer.

**Footpath Issues** - I can report that SCC have served an enforcement notice on the landowner of fields through which footpaths 14 and 15 pass but are completely overgrown.

**Street Lighting Improvements** - SCC has signed a contract for improvements and upgrades to streetlights which are their responsibility. If the Parish Council wish to take advantage of the possibility of advantageous rates for upgrading the streetlights in the parish, I can arrange for this to be investigated.

#### **District Councillor Mike Norris' Report:**

##### **Mid Suffolk and Babergh submit Joint Local Plan for examination.**

Mid Suffolk and Babergh District Councils have submitted their Joint Local Plan for independent examination by the Secretary of State. The final version of the plan was debated by Babergh and Mid Suffolk District Councils last year before councillors moved to submit the plan for examination by the Secretary of State, after a six-week period inviting representations on the legal compliance and soundness of the plan. These representations have now been published and submitted to the Planning Inspectorate for consideration during the examination. Hearing sessions for the

examination are expected to resume again in September following a change of date – enabling them to be fully inclusive, whilst also ensuring public safety during the COVID-19 pandemic. It is anticipated that the Stage 1 sessions, originally scheduled for June and July, will now take place over a concentrated period from September, with Stage 2 hearing sessions in mid-Autumn as originally planned.

### **Mid Suffolk communities receive close to £1 million in grants.**

Mid Suffolk District Council awarded community grants totalling £996,855 in the 2020/21 financial year – supporting the district's Covid response and enabling improvements to local community venues and sports and leisure facilities. During the year, council officers have worked with clubs and organisations in the district to identify need and ensure that vital grant funding has made a real difference to Mid Suffolk's communities.

The council has also acknowledged the key role of community groups, along with town and parish councils, in easing the challenges faced by residents during coronavirus, and a new dedicated Covid-19 Emerging Needs Grant opened last May to help the district through the peak of the pandemic. More than 60 organisations benefitted from funding, including good neighbour schemes, foodbanks and community outreach projects.

### **An update on Covid-19 in Suffolk.**

Regular bulletins continue to be produced to give a snapshot of the current Covid-19 situation in Suffolk - along with updates on the work being carried out as part of Suffolk's Local Outbreak Control Plan. ### **Next steps for councils' biodiversity and climate change plans agreed.**

Mid Suffolk and Babergh District Councils have given the go ahead for £97k for projects aimed at boosting biodiversity and tackling climate change across their districts.

### **MSDC/Babergh Tree, Hedgerow and Wildflower planting scheme application deadline extended.**

This scheme offers free trees and hedgerow plants to all parishes regardless of whether the planting is on council, parish, church, or private land. It is preferred that applications are submitted by Parish councils so that Parish local knowledge ensures that the right trees are planted in the right place. The major change to the scheme is that it is now a rolling programme of tree and hedge planting with no deadline for application submission, or dates by which trees or hedgerow plants need to be in the ground. It is not expected that all trees will be planted this year and there will be funding for subsequent years to come. There is also an associated scheme for wildflower planting.
