4b: Report of the County Councillor Cllr. K Welham

Cllr. Welham submitted a detailed written report which detailed Suffolk County Councils work concerning the year anniversary of the conflict in Ukraine, the role of the opposition parties at the Full County Council, progress towards Zero Carbon, the budget setting process for the 2023/4 financial year.

A full report was given on devolution in Suffolk and how this would impact the County Council and residents, which had unfortunately not been so forthcoming with successful bids for funding.

Subjects also covered were progress at Sizewell C, highways issues, school places and continued locality funding.

C Cllr. Welham was thanked for his continued support and contact with the Parish and it's Council.

4c: Report of the District Councillor

No report had been submitted specifically for this meeting due to the recent elections, but a written report from the newly elected Councillors Cllr. Ross Piper and Cllr. Terry Lawrence for Mid Suffolk District Council had been submitted to the Annual Parish Council Meeting.

4d: Report of the Parochial Church Council

A written report was received and **NOTED**. It detailed concerns about the south nave roof, church interior lighting and recent electrical survey.

A brief report detailing the electoral roll, election of officers sponsored cycle ride and special services throughout the year was also received and thanks were extended to all those involved at the Church for their continued involvement.
